with Toni Perrone

Toni's presentation will cover the genealogical resources in archives, books, microfilm and online databases, for the Hessen region of present-day Germany.

Toni Perrone is a founding member of the Immigrant Genealogical Society, the Immigrant Library in Los Angeles, CA, and the Temecula Valley Genealogical Society. She is the present day Chair of the German Interest Group in Temecula. Toni serves as President of the Pommern Interest Group at the Immigrant Library and on the Board of Directors of the Immigrant Genealogical Society. She volunteers at the Family History Center in Murietta and has for many years. She has been a speaker to various genealogical societies since 1981.

Toni has a background of 33 years of research in German and Italian ancestry, has received numerous awards from genealogical groups, has published articles in genealogical publications, two books on family lines and is currently working on a third.

Here it is March already. It will soon be spring, which I have to admit, is not my favorite season of the year. Why you ask – it is because I know it will soon be followed by summer which I really do not like. Give me fall and winter any time.

Spring does bring back many memories of my childhood. It was always this time of year that my mother would sit at the kitchen table and study all of the seed catalogs she had received just after Christmas. She was busy deciding what to plant in her garden and getting her orders sent in so that the seeds would arrive in plenty of time for spring planting. My parents had a very large garden every year with just about any vegetable you can think of.

I did not have to help with the planting because I was still in school when all that was done but I did have to help with the harvesting and “putting up” for winter. Maybe that is why I do not like summer. My mother canned or froze all of the veggies, she made tomato juice, all kinds of jellies. She even squeezed grapes to can grape juice. We had two sour cherry trees so she either froze the fruit or else made cherry pies and put in the freezer. I can't even begin to count how many sweet peas I shelled or how many green beans I had to snap. I know I often had a blister on my finger at the end of the day.

I wonder if that would be considered child abuse today? It was just a normal summer and all of my friends did the same thing. All of us certainly enjoyed the fruits of our labor all winter.

One other thing I had to help do, which I hated with a passion, was to help pluck the chickens so they could be either sold to our neighbors or put into the freezer for later eating. My parents bought 100 day old chicks each spring and there were usually only 6-8 hens left by the fall. They were kept for the eggs. I won't tell you what they became when they quit laying.

Next Computer Group Meeting – 16 March 2016

The next Computer Group meeting will be on Wednesday, 16 March 2016 at the Chula Vista Civic Center Branch Library (365 F Street in downtown Chula Vista, Calif.). There will be a “Beginning Computer Genealogy” class at 10:15 a.m. in the Conference Room, followed by the regular “Computer Group” meeting in the Computer Lab from 12:30 to 2 p.m., both led by Shirley Becker.

This is an experiment. We are giving it three months. Class will start at 10:15 a.m. in the Conference Room and go until 11:45 a.m. when we will break for lunch. It is called a “Beginning Computer Genealogy” group. If you have a laptop, you should bring it. Gary Brock will be demonstrating very basic computer tasks such as how to find tutorials and use them. We will move to the computer lab at 12:30 p.m. and stay until 2 p.m. Basic genealogy tasks are planned, such as going to a website, copying an item and placing that item in your database. We will use the lab computers at this point with a kind of fake database set up in Microsoft Word. We will delete those databases when we leave the lab. Hopefully, the attendees will have some basic knowledge at that point to follow on the computers. We want their input on what they would like to learn.

The expectation is that the attendees will follow up at home by practicing on things they will learn in class. In two months, if they practice we will try for more advanced things in the lab. If it doesn't work that way, we will answer requests for assistance and we will discontinue the extra class.

More Family Tree Maker News

Family Tree Maker genealogy software (both Windows and Mac versions) has been purchased by Software MacKiev (www.mackiev.com) from Ancestry.com, and will continue to be developed and sold. The Mac version of Family Tree Maker has been developed by MacKiev over the past seven years and licensed to Ancestry.com. Here is a set of Questions and Answers from the MacKiev website:

Q: When will Family Tree Maker start shipping again?

A: Both Mac and Windows editions are already available for download through our Online Store. Click [here](#) to get them now!

Q: I already own FTM 2014 or FTM Mac 3. Will I have to purchase this new version?

A: No. There will be a free update available soon. Please sign up for our mailing list to be notified when its available at www.mackiev.com/ftm.

Q: I own an older version of Family Tree Maker. Can I get a discount on an upgrade?

A: Yes! If you already have FTM 2012 or Mac 2 or earlier, you can get an upgrade to the new versions for just \$29.95 (vs. regular price \$69.95). To receive our upgrade offer, make sure you have signed up for our mailing list at www.mackiev.com/ftm. We will be sending out the upgrade offer on March 4th to everyone who has signed up by then.

Q: Will we need to transfer our trees in some way to use the new versions?

A: No. We are not starting over but rather building from FTM 2014 and FTM Mac 3 editions, so you will not need to move your trees – as you would if you were moving to some other family tree software than Family Tree Maker.

Q: Are your new versions of Family Tree Maker upgrades?

A: The Windows version is a somewhat updated version of FTM 2014, with as many bug fixes we could fit in. We've had more time to work on the Mac version and we have an update just about ready that will have some new features and some new background art added. Look for them the week of March 14th.

Q: What will the cost be for users new to Family Tree Maker?

A: Full new copies of Family Tree Maker will still be \$69.95, but we will have an introductory offer for \$49.95 when the product ships, so [sign up](#) to get notified if you'd like to take advantage of that. We will be sending out the upgrade offer on March 4th to everyone who has signed up by then.

Q: I have a copy of Family Tree Maker already for one computer. Do I have to buy additional copies at full price?

A: No, we will have a Family Pack Upgrade that will upgrade your license from one copy to three for just \$20, and those three copies may be a mix of Mac and Windows editions.

Q: I'm a Family Tree Maker user. Do I have to buy new versions of Family Tree Maker from software MacKiev in order for my Family Tree Maker to work with my subscription to Ancestry.com?

A: No, you don't need to purchase anything and your Ancestry.com subscription will continue to work with Family Tree Maker.

Q: Where will Family Tree Maker be sold?

A: Currently we plan to sell new FTM Mac and Windows editions through our online store (both downloads and physical discs will be available) and through other online resellers such as Amazon.com, and the Mac App Store.

She discussed the growth of the New York colonies and the ‘towns’ (not townships) that would be the primary source for vital records. The business portion of the meeting continued. Gary Brock presented the 2015 Annual Report and the Proposed Budget for 2016.

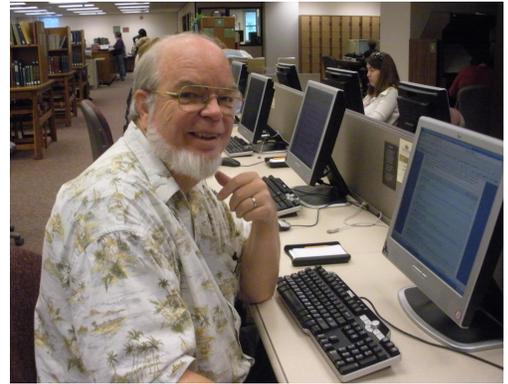

Research Group Meeting Review – 9 February 2016

There were 20 attendees at the Chula Vista Genealogical Society Research Group on Wednesday, 10 February 2016 at the Chula Vista Civic Center Branch Library Conference Room.

In the first hour, Randy discussed:

- * **RootsTech 2016 Conference** in Salt Lake City, including the program, Keynote and class videos, class syllabus, and parties, plus his photos and commentary about the conference. He has a RootsTech 2016 blog compendium posted at <http://www.geneamusings.com/2016/02/rootstech-2016-conference-blog.html>.
- * His one day of research at the Family History Library finding probate and land records for his ancestors.
- * The major announcement about the purchase of Family Tree Maker assets by Software MacKiev, and the Ancestry.com announcement of working with FTM and RootsMagic desktop software.
- * The addition of a large U.S. marriage collection on Findmypast.



In the second hour, the attendees discussed:

- * **Gary** encouraged attendees to register for all CVGS events on the CVGS webpage "Events" page.
- * **Karen Y.** noted that the FREE Escondido Family History Fair is Saturday, 5 March from 9 to 5. Registration is online. CVGS will have a carpool for those interested. More details to follow.
- * **Susi** asked how to deal with Smart and other Matches on MyHeritage. Users can compare and accept (or not accept) information one person at a time, or many persons at a time. There are also Instant Discoveries which can add 10 or more persons to your MyHeritage tree based on information from other MyHeritage trees. Record Matches are records in MyHeritage record collections that might apply to your persons in your MyHeritage tree.
- * **Diane** asked about the proper way to make gravestone inscriptions readable. The group said to not use organic or corrosive material like shaving cream or flour, to use water to create contrast, to use a reflector to light up a darker gravestone face, to mind the shadows, and to use gravestone rubbings with butcher paper and a crayon.
- * **Karen S.** asked about finding digital newspaper articles. The group suggested The Ancestor Hunt blog (www.theancestorhunt.com) for lists of available digital newspaper issues, the free Chronicling America site, state and regional newspaper collections, and commercial sites like Ancestry.com, Newspapers.com, GenealogyBank, NewspaperARCHIVE, Findmypast and MyHeritage.
- * **Bobbie** visited the Lake County, Illinois deed office and obtained several deeds from their record books. She also investigated the plat maps available.
- * **Susan** has had good fortune with Find A Grave requests in cemeteries in Illinois, Indiana and Ohio. She wanted to "pay it forward" and accepted several requests for Singing Hills Memorial Park in San Diego County. When she went there to inquire about the location of the graves, the company told her that they would not provide them because they have been sued by people who complained about similar requests and lost the suit.
- * **Gary's** Roff saga continues - he found a Yates County, New York database that has information about his ancestors, Philip 1, Philip 2, and Solomon.
- * **Susan** also had a plaque installed on the Fort Rosecrans National Cemetery marker for her father.

Long Lost Family on TLC Starting March 6th

The new TV show, *Long Lost Family*, features the highly emotional and touching stories of people who have suffered a lifetime of separation and are yearning to be reunited with their birth parents and biological families or find children they had to place for adoption long ago. Either because of circumstance or fate, they've barely – if ever – met. **The TLC (Channel 36 on Cox Cable) series premieres on Sunday, March 6th at 10 p.m. PDT.**

Relative Race on BYUtv Starting February 28th

A new genealogy-related television series premiered on 28 February, called *Relative Race*. This is basically Genealogy meets *Amazing Race*. It features four married couples as they travel across the US in search of long lost relatives, armed with only paper maps, a rental car, a \$25 per diem and a flip phone.

Using the science and technology provided by AncestryDNA, the couples embark on a journey that starts in San Francisco, ends in New York City and leads them to unknown relatives along the way. Cameras follow all four teams as they drive across the country -more than 4,500 miles - in just ten days, stopping each day to complete a challenge and find (and stay with) their newly discovered relatives in a different city. At the end of each day, the team that finishes last receives a strike; after three strikes, teams are eliminated and the remaining teams travel to NYC for the grand finale where there is a \$25,000 grand prize for the winning couple.

Family Tree Maker News (concluded)

Q: Will Software MacKiev be supporting FamilySearch?

A: Yes. We'll be implementing Family Search in future versions of Family Tree Maker. Ancestry had actually started implementing Family Search some time ago in both Mac and Windows versions. The folks at Family Search have already reached out to us and we hope to have Family Search in FTM versions by the end of 2016.

Q: What about TreeSync? Will we still be able to keep our trees in synch with the tree we have on Ancestry.com?

A: As Ancestry has announced, you will continue to be able to access your data through TreeSync through December 31, 2016 using current versions of Family Tree Maker. After January 1, 2017, while TreeSync will not be supported by Ancestry for the version you have now, you will still be able to access your trees on Ancestry.com and keep your online tree consistent with the one on FTM through new technologies being developed together by Software MacKiev and Ancestry.

Q: Do I need to re-register with Software MacKiev?

A: No, you do not need to re-register with Software MacKiev for your software to continue working. You might want to sign up for our mailing list though to find out about new product introductions and upgrades. Click [here](#) to sign up.
